FALL 2024 FORWARD

Participating in SynaTek's 2024 Fall Forward Program could not be easier. Simply make a commitment to purchase by December 6, 2024, take delivery by the dates outlined below and remit payment by June 6, 2025.

Synatek Rewards Program

Participants in the 2024 Fall Forward Program will be able to benefit from rebates of up to 10% from purchase commitments made by December 6, 2024. Agency products offered by SePro and FMC are not eligible for SynaTek Rewards. Please refer to the end user programs offered by each of these manufacturers for a complete detail of eligible rebates.

Rebate Tiers as follows:

\$2,500 - \$4,999	2%
\$5,000 - \$19,999	4%
\$20,000 - \$39,999	6%
\$40,000 - \$59,999	8%
\$60,000 - Above	10%

For example, if a \$20,000 purchase commitment was made from qualifying manufacturers by December 6, 2024 you would receive a \$1,200 rebate based upon a rewards level of 6%. Rebates will be paid out by August 31, 2025 provided that shipment of the product takes place by the dates outlined below and payment is received by June 6, 2025.

*In the event that the product is not shipped or paid in full within the terms of the Fall Forward Program then all rebates will be forfeited.

Extended Delivery & Payment Terms

Participants in the 2024 Fall Forward Program will benefit from extended delivery and payment terms. All purchase commitments received by December 6, 2024 will be able to defer delivery until the dates outlined below with payment for the product not being due until June 6, 2025.

Delivery Deadlines

Packaged: March 31, 2025

Granular: March 31, 2025

Liquid: July 31, 2025

*In the event that the product is not shipped or paid for within the terms of the Fall Forward Program then all rebates will be forfeited.

Early Pay Discounts

The following payment discounts are available for customer's who elect to pay for their early order commitment prior to the June 6, 2025 due date.

6% if paid by December 13, 2024

3% if paid by March 31, 2025

2% if paid by April 30, 2025

Product Swap

Participants in the 2024 Fall Forward Program will be able to make purchase commitments from qualifying manufacturers without needing to fully predict disease and insect pressures for the coming season. The Fall Forward Product Swap will allow you to exchange up to 25% of your control product purchases (excluding control product on fertilizer) until July 10, 2025 once you have a stronger gauge of your course's particular needs. The exchange privileges are offered on a one-time basis and must be exchanged for products with an equal or greater price compared to the products being exchanged. For example, if you made a \$10,000 purchase commitment by December 6, 2024 for eligible products you would be able to exchange up to \$2,500 of those products on a one-time basis by July 10, 2025 with a minimum of \$2,500 in other eligible products.

Price Guarantee

Participants in the 2024 Fall Forward Program will be able to make purchase commitments on all control products (excluding control product on fertilizer) without the budgetary stress and strain of trying to predict the future of product pricing. The Fall Forward Price Guarantee will ensure that the product price you receive in the commitment period offered through December 6, 2024 will be the lowest offered price through August 31, 2025. If prices decline you will not only receive the lower price for any subsequent purchases, but you will also be credited the difference for any products previously purchased. For example, if you committed to purchase one case of Iprodione by December 6, 2024 at \$256.00 and then on July 6, 2025 the case price dropped to \$200.00 we would automatically rebate you the \$56.00 difference as a result of the change in price. Furthermore, if prices increase you will not see any change in your pricing structure. For example, if you committed to purchase one case of Iprodione by December 6, 2024 at \$256.00 and then on July 6, 2024 the price increased to \$290.00 per case you would continue to receive the \$256.00 per case price offered to you during the commitment period. **Excludes all MLP and Agency pricing.**

Shipping

- Minimums for free delivery will vary based upon regional zone. Any order that does not meet the minimum for free delivery will be charged the actual cost for shipping.

Delivery Zone minimums are as follows:

- o Zone 1 - \$ 750
 - o Zone 2 - \$ 3,000
 - o Zone 3 - \$ 5,000
 - o Zone 4 - \$10,000
 - o Zone 5 - Not Available for Sale
- Any order that does not meet the minimum for free delivery in Zone 1 will be charged \$75. Any order that does not meet the minimum for free delivery in other zones will be charged the actual cost for shipping.
 - All in-stock orders will ship within five business days. Expedited service may be available at no additional charge when requested.
 - Liftgate and Pallet Jack service is available at no additional charge when requested.

Payment

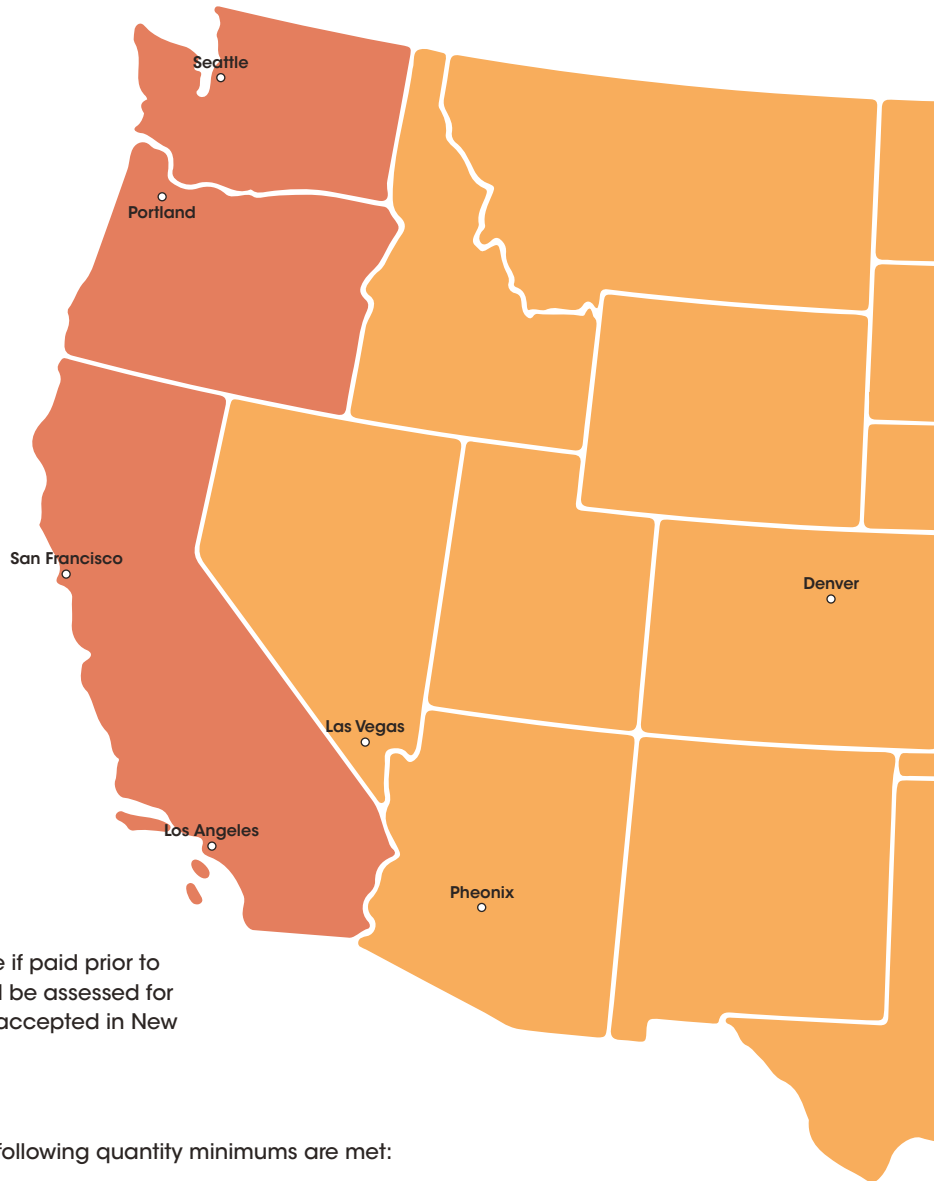
- Standard payment terms are 30 days unless other wise stated through a pre-approved arrangement or early stocking program.
- SynaTek accepts Visa, MC or AmEX with no surcharge if paid prior to delivery or at customer pick-up. A 3.0% surcharge will be assessed for all cards if paid after this time. Credit cards are only accepted in New York if paid prior to delivery."

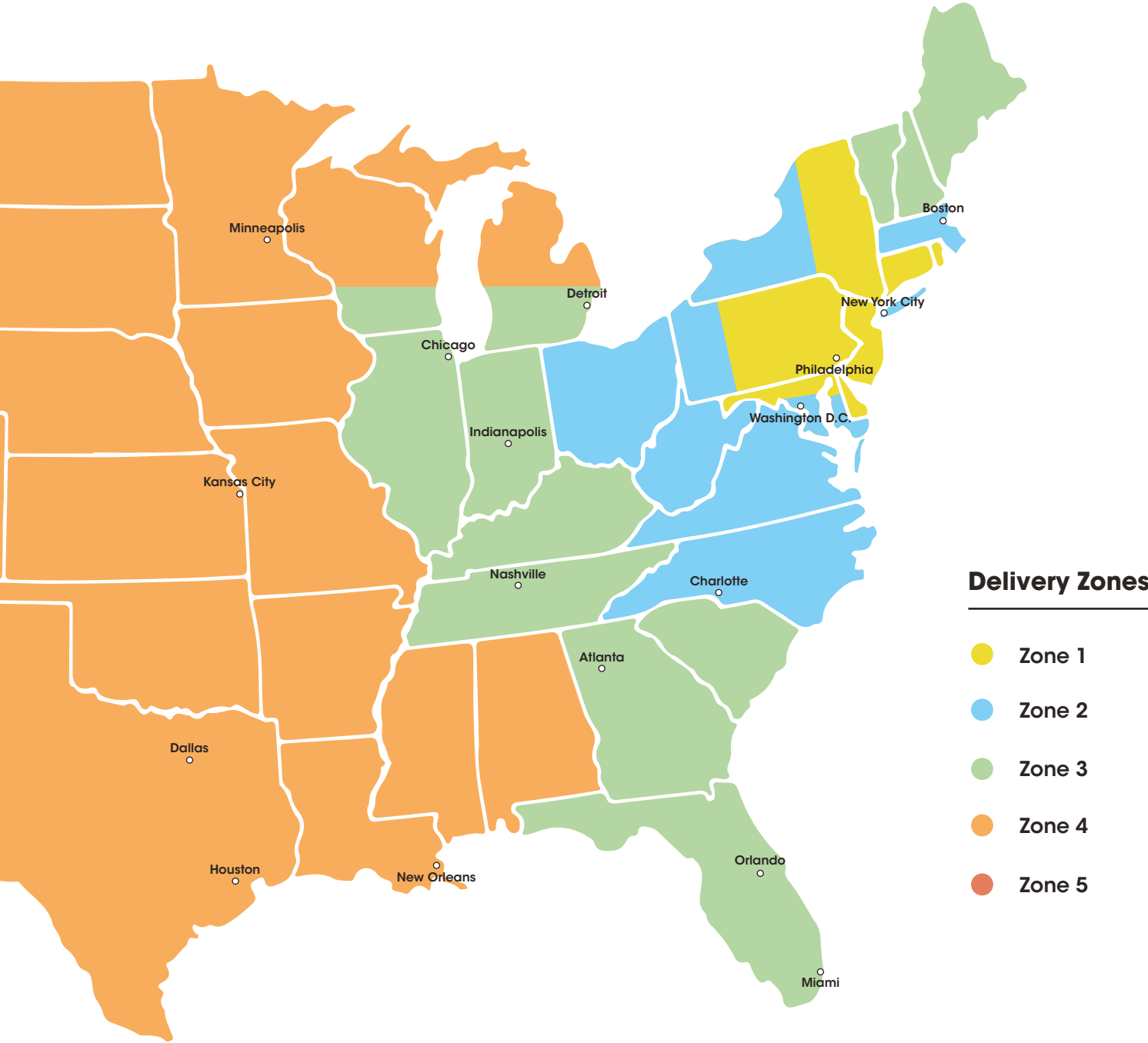
