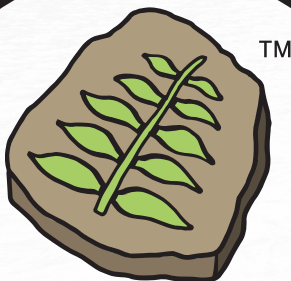

Description

Paleo's™ purpose is to enhance the plant's ability to take in essential nutrients and improves soil structure.

Application

To apply the applicable rate of 1 Gallon per Acre of Paleo, use the following rate: 3 ounces per 1,000 sq.ft.

Tank Mixing

Add half the total water to the tank. Then add the recommended amount of Paleo. Add any liquid concentrate materials, followed by water-soluble materials. Fill spray or mix tank with remainder of water and agitate.

Precautions

Avoid infiltration of large quantities into drains, surface water, ground water and soil. Apply in a water carrier at no less than 1 gallon per 1,000 sq.ft. **DO NOT MIX WITH GLYPHOSPHATE.**
